First Reading

Background:

The proposed program name (Integrated Agricultural Sciences and Technology, M.S) will reflect all options that are housed in the Huntley College of Agriculture: Agricultural Leadership, Animal Science, Food Science & Technology, Plant Science, and Sustainable Fashion & Textile. Furthermore, the term "technology" will indicate that the program covers emerging and cutting-edge topics in the various disciplines. The CSU degree program code of 49021 covers the Natural Sciences and Life Sciences, while the CIP code of 30.1801 includes programs with a combined or undifferentiated focus on one or more of the physical and biological sciences. Therefore, these codes encompass the Agricultural Leadership, Animal Science, Food Science & Technology, Plant Science, and Sustainable Fashion & Textile options.

Moreover, the 30.1801 CIP is a STEM code, which reflects the nature of the program and also enhances the possibility of extended internship opportunities for international students after graduation through the OPT program.
